From April 2024, Medical Service Subsidy Coupon will be given to children 18 years old and below

If you show the coupon* at the hospital, you will not have to pay for hospitalization, hospital visits, or medicine.

*It can also be used from the time you turn 18 until Mar. 31.

Application is required to families with children who are in 1st and 2nd year High School.

A letter will be sent. Please apply by Mar.

The coupon will be sent within March.



Families that fall into the following categories will not have to pay for their children's hospitalization and hospital visits from April 1.

1. If you are a single parent.
2. You are imposed to Residence tax.

The Medical Service Subsidy Coupon will be sent within March.

Please make sure to show it at the hospital.

Be careful of Grass Fires

In winter, when the wind blows strong and the air is dry, fires are more likely to start.

Do not burn garbage from home by yourself.

If you wish to burn cut grass, please contact the Agriculture, Forestry and Fisheries Division and Kamogawa Fire Department.

1. Always have a fire extinguisher or a bucket with water ready.
2. Do not burn grass on a strong windy day.
3. To prevent spreading of fire, do not leave burning grass unattended.
4. When finished, always check if the fire is out.
5. In case of fire, be prepared to call the fire department (119) immediately.
