★Amount to be received: 30,000 yen per child

★Qualified families and receiving period:

1 Families who will receive the child support allowance for Sep. 2025.

→ No need to apply. To be deposited around late-February.

※To parents who got divorced or will get divorced between Oct. 1, 2025 and Mar. 31, 2026, and the person who will receive the child support allowance will change. → Need to apply.

2 If child was born/will be born between Oct. 1, 2025 and Mar. 31, 2026 and is registered in Kamogawa City.

→ Need to apply.

3 Parents working at City Hall → Need to apply.

★Please apply by Apr. 30 (Thu.)
