# TAX INFORMATION

(FEBRUARY 18TH TO MARCH 15TH)

## Final Income Tax Returns with the Kamogawa Tax Office

City hall employees will correspond with those coming to file income tax and final income tax returns from the city hall. They will be able to help with simple or brief inquiries about filing but, you may have to go to the Tateyama Tax Office for more complicated filings. Also, anyone filing income taxes or materials concerning special deductions on your declarations before February 15th, please go to the Tateyama Tax Office directly.

### For More Complicated Final Income Tax Returns

Please directly file with the Tateyama Tax Office or e-Tax online if;

- ▽ Filing housing loans and other special deductions
- ▽ Filing real estate, stocks, or any additional income, as well as separate taxes on retirement income and forestry.
- ▽ Filing virtual business transactions
- ▽ Somowone who hasn't collected necessary documents (like your statement of earnings, or an itemized income document)
- ▽ Filing a blue tax return etc.



### Necessary Materials for Filing

- ▽ A document indicating income: statement of earnings, public pension tax certification, business, farming, or real estate itemized income statements, etc.
  - ▽ All documents relating to deductions: National Health Insurance Tax, Nursing Insurance Tax, Medical Insurance for the Elderly, Pension System receipts, Life Insurance, etc.
  - ▽ ID: My Number Card, something confirming that number, Foreign Residence Card
  - ▽ A personal seal (inkan)
  - ▽ For those filing disabilities : your government-issued disability notebook, or rehabilitation notebook
  - ▽ Those getting a refund, please bring your bank information and something to confirm your identity
- ※ Depending on the contents of your filing other documents may be necessary.
