# Starting October 1st: Consumption tax rates up.

Come October tax rates will raise to a standard 10% consumption tax and 8% consumption tax on foods (outside of alcohol and restaurants), and newspapers. For detailed information and special information for business owners, please search Tax Rebates under the National Tax Agency.

# Special Offer: Kamogawa Premium Gift Certificates

Consumption tax will go up starting in October. In an effort to help those most affected the city, there will be "Kamogawa City Premium Gift Certificates" to those raising children and those who are exempt from municipality taxes. You will need a "Purchasing Coupon" in order to be able to claim this offer. There will be mailed out to eligible people starting in September. People exempt from municipality tax will have to apply for this coupon.

You can buy 5,000 yen worth of credit, for only 4,000 yen! This can be used at participating businesses in Kamogawa.

They will be sold from October 1st, 2019, to January 27th, 2020. (The certificates will have to be used by February 16th)

People Exempt from Municipality Tax: If you were a registered citizen as of January 1st of this year but were exempt from municipality taxes. (those marked as dependents at the beginning of 2019 or receiving public assistance are ineligible.) You are able to buy up to 5 sets of the gift certificates. You MUST send in your application to be able to purchase (received by mail in late July) by Friday, November 29th in order to be able to buy.

**People Raising Children:** If you have a child born between April 2nd, 2016 and through September 30th of this year, you are eligible for this offer. You are allowed to purchase 5 sets of certificates times the number of children who fall within this time period. No application is necessary.

\*Purchasing Coupons to be able to purchase will be sent out in September Coupons can't be reissued.
