DAMAGE CERTIFICATION • VICTIM OF DAMAGE CERTIFICATION

[Damage Certification]

Depending on the status of your house, you may be able to receive certification and support for these damages. Please appeal through the Tax Division to find out if you are able to get these benefits.

[Victim of Damage Certificate]

If you have suffered damage to other parts of your estate (other than your house) i.e. personal belongings, you may be able to make an insurance claim and get a payment for these damages.

Who can apply: People with damage to their house, estate, personal belongings etc.

What you need: Pictures or something confirming the damage (multiple will be necessary), a written estimate of the damage (you may be able to bring this later), and a personal seal.
