Filing Income Taxes/ Residency Taxes

Febraury 16th - March 15th

People who had any income during 2020, will have to file income taxes. You may have tax deductions or tax exemptions which will change what you owe in income tax. The city will take measures to allow people to send in or file without coming to the city hall if they don't want to.

For those filing for Residency Taxes:

You can send you paperwork by mail. If it is your first time, you can hand in your paperwork at any branch offices, or even the Citizen Service Center on AEON 4F. Address your paperwork to " Kamogawa City Hall, Tax Division".

For those filing Income Taxes:

We recommend you use the National Tax Agency homepage. After filing your final income e-Tax statements you can print the completed forms and send them to the Tatevama Tax Office. If you would like more information please check the National Tax Agency homepage.

If you MUST come to the city hall:

- 1. If your temperature is over 37.5°C, stay home
- 2. If you have a cough, fever, etc. do not come
- 3. Wear a mask
- 4. Come alone or with few people
- 5. Use the hand sanitizer at the city hall entrance

*There are often many people who come during this time of year. You may have to wait guite a long time.

Traffic accident rates are much higher when it is dark out. If you go for a walk or go out at night, wear bright or reflective clothing. It may be a good idea to also carry a light so that driver's can see you when it's dark out, like early in the morning and late in the evening. When driving in the dark, you should also be extra cautious of people walking.
